Job Search: Urban League continued to offer bi-weekly job search workshops on interviewing skills, resume writing, soft skills and placement during 2010 for 868 individuals. Workshops were provided for 377 people, 550 clients received job referrals and 115 clients were successfully placed in jobs. Pre-employment services were also provided for 62 youth who were placed in summer youth internship program.

Community Case Management: We helped 820 clients meet their urgent needs such as housing, food, clothing and transportation. We provided job opportunities and bus passes for 105 clients. We provided rent and utility assistant for 37 clients who are homeless or on the verge of being homeless.

Economic Development: As a HUD-certified housing counseling agency, Urban League continued to counsel clients in taking the right steps to avoid foreclosure. During 2010, this program provided housing counseling and financial literacy workshops for 943 clients.
