CIVIC ENGAGEMENT/ADVOCACY: Mobilizes organizations and individuals to engage in activities to close the gaps in education and other areas identified in the State of Black Fort Wayne (SOBFW). During 2008, 41 copies of the Organization's State of Black Fort Wayne 2003 document was distributed, most of them for use as texts in classes at Indiana University - Purdue University at Fort Wayne.

ECONOMIC DEVELOPMENT: As a HUD-certified housing counseling agency, Urban League continued to counsel clients in taking the right steps to avoid foreclosure. During 2008, this program provided housing counseling and financial literacy workshops for 751 clients.

JOB SEARCH: Continued to offer bi-weekly job search workshops during 2008. The information provided in each workshop included an overview of employment services, referral processes and assessment requirements, as well as resume writing, interview and job retention strategies. In 2008, 1,402 individuals received employment assistance from the Fort Wayne Urban League. Workshops were provided for 470 persons, gave 502 clients job referrals and successfully placed 130 clients in jobs.
